About the London Symphony Orchestra

The London Symphony Orchestra was established in 1904, as one of the first orchestras shaped by its musicians. Since then, generations of remarkable talents have built the LSO's reputation for uncompromising quality, and inspirational repertoires.

Today, the LSO is ranked among the world's top orchestras, with a family of artists that includes Chief Conductor Sir Antonio Pappano, Conductor Emeritus Sir Simon Rattle, Principal Guest Conductors Gianandrea Noseda and François-Xavier Roth, Conductor Laureate Michael Tilson Thomas and Associate Artists Barbara Hannigan and André J Thomas.

The LSO is Resident Orchestra at the Barbican in the City of London. The Orchestra reaches international audiences through touring and artistic residencies – in cities including Paris, Dortmund and Tokyo, at the Aix-en-Provence Festival, across Australasia and Latin America, and with the Music Academy in Santa Barbara – and through digital partnerships and an extensive programme of live streamed and on-demand online broadcasts.

Through a world-leading learning and community programme, LSO Discovery, the LSO connects people from all walks of life to the power of great music. Based at LSO St Luke's, the Orchestra's community and music education centre and a leading performance venue on Old Street, LSO Discovery's reach extends across East London, the UK and the world through both in-person and digital activity.

LSO musicians are at the heart of this unique programme, leading workshops, mentoring bright young talent, performing at free concerts for the local community and using music to support adults with learning disabilities. LSO musicians also visit children's hospitals, and lead training programmes for music teachers.

The ambition behind this work is simple: to share the transformative power of classical music with people who would not normally experience it. The impact is unrivalled, and every year, LSO Discovery reaches thousands of people of all ages.

In 1999, the LSO formed its own recording label, LSO Live, and revolutionised how live orchestral music is recorded, with over 150 recordings released so far. Overall, the LSO has made more recordings than any other orchestra.

As a leading orchestra for film, the LSO has entertained millions with classic scores for Star Wars, Indiana Jones, The Shape of Water, and many more. The LSO also uses streaming services to reach a worldwide audience totalling millions of music-lovers who listen online every month.

Through inspiring music, educational programmes and technological innovations, the LSO's reach extends far beyond the concert hall. Thanks to the generous support of The Corporation of the City of London, Arts Council England, corporate supporters and individual donors, the LSO is able to continue sharing extraordinary music with as many people as possible, across London, and the world.

About the Role

The LSO is seeking a highly organised and experienced Corporate Partnerships Executive to join its dynamic Development team, account managing key strategic partnerships and supporting the Senior Corporate Partnerships Manager with approaches to prospective partners.

As the City returns to life post-pandemic and an increased sense of optimism, we are seeking to rebuild our corporate fundraising income, drawing in new supporters to complement our existing portfolio of sponsors and corporate partners. Partners of the LSO enjoy an association with our reputation for success, innovation and excellence. All LSO partnerships are tailor-made to deliver measurable business outcomes, greater social impact, and enhance employee well-being, making them a highly cost-effective investment for any company. The successful candidate will work closely with the Senior Corporate Partnerships Manager and Head of Development to account manage a range of current corporate partners, and develop new sponsorship opportunities, taking into account current corporate priorities and sector trends. This is an exciting time to join the team, as we develop our engagement opportunities with companies to ensure they remain current and attractive in the new business climate.

The Development Team

The LSO's Development Team raises over £3 million per year from the private sector, with ambitious plans to grow fundraised income over the next three years. Comprising 13 members of staff, the team's objective is to generate income from corporate supporters, trusts and foundations, individual donors, special events and the statutory sector,

in support of the LSO's activities both in the UK and abroad.

Location

Based at the LSO's offices at the Barbican Centre, with the option to work remotely for up to two days per week.

37.5 hours per week. Core hours are 9.30am to 6.00pm, Monday to Friday. Some additional evening and weekends are required at LSO concerts, on a rota, with a time-off-in-lieu policy in place.

Key Responsibilities

Account manage a range of current LSO strategic corporate partnerships

- Lead on relationships with a range of the LSO's strategic corporate partnerships, delivering benefits both in the UK and abroad
- Work with the Senior Corporate Partnerships Manager and Events Manager to deliver mutually beneficial events with strategic corporate partners
- Maintain and deliver annual communication plans for corporate supporters, including event invitations and key updates as appropriate
- Liaison with Finance and Marketing colleagues for the administration of sponsor invoicing, acknowledging and recording of payments received, and ensuring current supporters and credited in line with agreed expectations

Identifying and engaging a new portfolio of prospective corporate supporters

- Research and identify possible corporate partners for the LSO, preparing updates to discuss with the wider LSO Corporate Development team and maintaining clear records and systems
- Work collaboratively with the Senior Corporate Partnerships Manager on initial contact with cold prospects, securing introductory meetings for the LSO, preparing briefings and attending the meetings with a colleague from the Development team
- Identify possible corporate supporters for particular areas of the LSO's work, including Barbican concerts, international tours, accessible ticket schemes, education and community projects, major fundraising galas, as well as broader initiatives such as improving sustainability and fulfilling the LSO's DEI plan

- Work within the Corporate Development team to develop ongoing cultivation plans for the most promising contacts and prepare compelling proposals as needed, and maintain prospect planning within a wider corporate fundraising strategy
- Work with the Senior Corporate Partnerships Manager to develop new opportunities for support, and build a strong prospect pipeline, taking into account current sponsorship and corporate support trends
- Keep abreast of trends in corporate partnerships in the arts and broader charity sector to ensure the LSO continues to offer competitive packages, attending networking events where relevant

Wider work as part of the Development team

- Work with the Development Coordinator to record all communication with potential supporters on the Development database (Raiser's Edge)
- Attend evening and occasional weekend concerts and events, on a rota basis, to meet the demands of the post
- Assist with other Development activities including largescale fundraising events, young professional networking events and special appeals
- Undertake any other duties as reasonably requested by the Senior Corporate Partnerships Manager or Head of Development
